RESOLUTION NO. 2026-55

WHEREAS, February 24, 2026, the Yuba County Board of Supervisors, pursuant to California Government Code section 8630 and Yuba County Ordinance Code section 4.20, ratified and continued the Proclamation of Local Emergency dated February 19, 2026 by the County Director of Emergency Services of a local emergency due to the failure of Yuba Water Agency's New Colgate Powerhouse Penstock, which occurred on February 13, 2026; and

WHEREAS, California Government Code section 8630(c) requires the Board of Supervisors to review, at least every sixty (60) days, the need for continuing the local emergency until termination of such emergency; and

WHEREAS, the Board of Supervisors does hereby find that the findings made in Resolution No. 2026-10 continue to exist and local resources remain insufficient to cope with the effects of said emergency and require enhanced multi-agency coordination and resources beyond those routinely available to the County of Yuba; and

WHEREAS, pursuant to California Government Code section 8630(d), the Board of Supervisors shall terminate the local emergency as soon as reasonably possible.

NOW, THEREFORE, BE IT RESOLVED, by the Yuba County Board of Supervisors that the local emergency proclaimed by the Director on February 19, 2026, approved and ratified on February 24, 2026, is hereby continued.

BE IT FURTHER RESOLVED, that during the existence of said local emergency, the powers, functions, and duties of the emergency organization of this County shall be those prescribed by state law, by ordinances, and resolutions of the County of Yuba; and

BE IT FURTHER RESOLVED, that the local emergency shall be renewed at least every sixty (60) days until its termination is proclaimed by the Board of Supervisors.

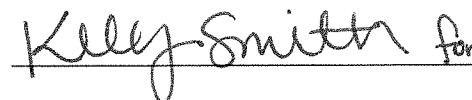

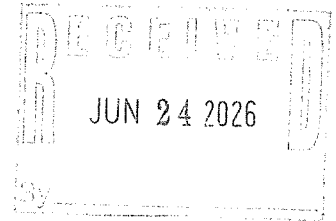

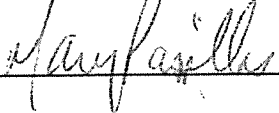
