The plan shall include the general vicinity of the proposed site, limiting dimensions and depth of cut and fill, and location of any buildings or structures when work is to be performed, and the location of any buildings or structures within 15 feet of the proposed grading (please see attachment "Requirements for Non-Engineered Grading Plans". Grading in excess of 5,000 cubic yards shall be performed in accordance with the approved grading plan prepared by a civil engineer (please see attachment "Requirements for Engineered Grading Plans").**

**4. If grading over an acre, you must submit a Notice of Intent with the California Regional Water Quality Control Board. Your grading permit can not be issued until we receive two copies of your accepted SWPPP with WDID #.**
